**RESOLUTION NO. 18-03**

**RELATIVE TO RETENTION OF CONSULTANTS, LEGAL COUNSEL, AND  
ADMINISTRATIVE LAW JUDGES FOR THE GUAM PUBLIC UTILITIES  
COMMISSION**

**WHEREAS**, the Guam Public Utilities Commission (“PUC”) is an autonomous instrumentality within the Government of Guam;

**WHEREAS**, the PUC has the authority to retain Consultants, Attorneys and Administrative Law Judges;

**WHEREAS**, the PUC has concluded that it is in the public interest to retain Consultants, Attorneys and Administrative Law Judges in a transparent and fair manner pursuant to the established procedures in the Procurement Laws of Guam; and

**WHEREAS**, the PUC has determined that it requires the services of Attorneys, Administrative Law Judges, and Consultants to advise it upon pending utility matters within its jurisdiction;

**WHEREAS**, the PUC has issued RFP Nos. 001-FY2018, 002-FY2018, 003-FY2018, 004-FY2018, 005-FY2018, and 006-FY2018 to procure the services of Consultants, Legal Counsel, and Administrative Law Judges;

**WHEREAS**, upon conducting a fair process in accordance with the procurement laws of Guam and upon due and proper evaluation of the offerors and their respective qualifications, the Commissioners have selected, as the most qualified offerors: Daymark Energy Advisors, Concentric Energy Advisors, and Georgetown Consulting Group Inc. as Power/Water Consultants; MSW Consultants as Solid Waste Consultant; Slater, Nakamura & Co. LLC as Port Authority Consultant; Slater, Nakamura & Co. LLC as Telecommunications Consultant; Anthony Camacho as Legal Counsel;

Frederick J. Horecky as Chief Administrative Law Judge, and Joephet Alcantara as Administrative Law Judge;

**WHEREAS**, the PUC has now negotiated contracts with each of the selected Offerors, and the PUC and such Offerors have agreed to contract terms and pricing;

**NOW THEREFORE**, in due consideration of the above recitals and for good cause shown, the PUC hereby resolves that:

1. The Consulting Services Agreements with Daymark Energy Advisors, Concentric Energy Advisors, and Georgetown Consulting Group Inc. for water/ power are hereby approved;
2. The Consulting Services Agreement with MSW Consultants for solid waste is hereby approved;
3. The Consulting Services Agreement with Slater, Nakamura & Co. LLC for the Port Authority is hereby approved;
4. The Consulting Services Agreement with Slater, Nakamura & Co. LLC for telecommunications is hereby approved;
5. The Consulting Services Agreement with Anthony Camacho for Legal Counsel is hereby approved;
6. The Consulting Services Agreement with Frederick J. Horecky for Chief Administrative Law Judge is hereby approved;
7. The Consulting Services Agreement with Joephet Alcantara for Administrative Law Judge is hereby approved;
8. PUC Legal Counsel is further instructed to issue Notices of Final Award to the selected applicants and all other applicants who applied to the Requests for Proposals.
