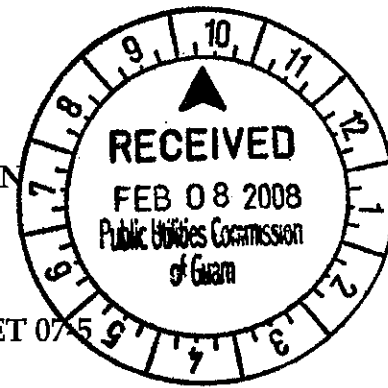

ARBITRATION PROCEEDING
INTERCONNECTION AGREEMENT
BETWEEN GTA TELECOM LLC
AND GUAM CELLULAR AND PAGING, LLC

DOCKET 07-5



Memorandum Order

By Order dated November 16, 2007 [*Order*], the Guam Public Utilities Commission [*PUC*] suspended further regulatory proceedings in this docket until Guam Cellular and Paging, Inc. [*Guamcell*] brought itself into compliance with PUC Rule 40[a], which requires that a party pay regulatory fees within 30 days of invoice. The Order authorizes the undersigned to establish a new schedule for further proceedings in this docket upon Guamcell's compliance with Rule 40, which has now occurred. Accordingly, the purpose of this Memorandum Order is to establish this new schedule.

1. Pursuant to section 7[a] of PUC's August 13, 2007 Decision herein [*Decision*], the parties were directed, within 30 days to file a complete, final copy of the interconnection agreement [*ICA*], which contains the provisions negotiated by the parties and which incorporates PUC's resolution of the open issues submitted for arbitration, including, without limitation, the amendment of: a) ICA § 1.58, §3.2 and other sections pursuant to Decision section 6[a]; b) ICA §5.4 and other sections pursuant to Decision section 6[b], and c) ICA sections regarding transit traffic pursuant to Decision section 6[c]. Due to post-hearing motions, this requirement has not yet been met. A new compliance date of March 10, 2008 is hereby established for this requirement. Upon an adequate filing by the parties pursuant to this requirement, PUC shall issue a Final Order, the date of which drives the other deadlines established in the Decision.¹
2. Pursuant to Decision section 6[b], on or before March 31, 2008, GTA Telecom LLC [*GTA*] shall file its position regarding: i] whether the interim entrance facility rates as approved by the Decision include all charges for entrance facility services; ii] whether the same are just, reasonable and non-discriminatory, and if not then propose rates for these services which satisfy this standard; and iii] the need and scope for a cost of service study for these rates. On or before April 18, 2008, Guamcell and PUC's regulatory consultant Georgetown Consulting Group [*GCG*] may

comment on the GTA filing. Further proceedings will be scheduled after review of these filings.

3. Pursuant to Decision section 6[c], GTA shall on or before March 14, 2008 submit for review and comment a proposed scope for the transit traffic cost of service study. Guamcell and GCG may file comments regarding the study scope on or before March 28, 2008. On or before April 9, 2008 the undersigned will enter a ruling on the proposed study scope.
4. Pursuant to Decision section 6[d], the undersigned will issue a ruling on the calling card issue on or before February 29, 2008, which shall be incorporated into the ICA, which will be filed pursuant to section one of this Memorandum Order.
5. On or before March 31, 2008, the parties shall file their position regarding the allocation of the expense of the cost studies required under Decision sections 6[b] and [c].

Attachment A summarizes the schedule of further proceedings, which is established by this Order.

The parties should notify me if they believe that either a settlement conference or a conference call would facilitate their compliance with the requirements of this Order or the negotiation of permanent entrance facility and transit traffic rates.
