## **RESOLUTION NO. 19-01**

RE: EXTENSION OF CONSULTANT SERVICES AGREEMENTS FOR FY2020

Whereas, the contract term for the first year of each agreement will end on September 30, 2019;

Whereas, the Commission is satisfied with the services rendered by all of its nine Consultants and desires that said Consultants continue to provide services to the PUC for the following fiscal year;

NOW THEREFORE, in due consideration of the above recitals and for good cause shown, the PUC hereby resolves that:

- The nine contract service agreements referenced above are hereby extended for a
  period of one year; all existing terms and conditions of the agreements shall remain
  in effect.
- 2. The PUC ratifies and affirms all of the nine contract services agreements.
- The contract service agreements are in the best interests of the PUC, the ratepayers, and the Territory of Guam. Without consultants, PUC could not perform its statutory duties and obligations.
