RESOLUTION NO. 20-04

RE: AUTHORIZATION TO RETAIN PAYROLL SERVICES FOR THE PUC

Whereas, the Guam Public Utilities Commission ("PUC") is an autonomous instrumentality within the Government of Guam;

Whereas, pursuant to 12 GCA §12103, Operation of Commission, the Commission is empowered to retain, on an as needed basis, those professional services required by the Commission in the performance of its duties;

Whereas, the PUC has recently created two employment positions for Commission personnel, PUC Administrator and part time Administrative Assistant to the Administrator;

Whereas, the Commission has determined that it would be preferable to have payroll services handled by an independent provider of such services, as the Commission has not previously hired employees or handled such services;

Whereas, Sanford Technology has submitted a proposal to the PUC to provide comprehensive payroll services for two employees at a reasonable annual cost of \$1,400.00; and

Whereas, the PUC and Sanford Technology desire that the PUC retain Sanford Technology to provide such payroll services;

NOW THEREFORE, in due consideration of the above recitals and for good cause shown, the PUC hereby resolves that:

1. The PUC is authorized to retain Sanford Technology for provision of payroll services at an annual cost of \$1,400.00 including any subsequent additional


reasonable charges that are approved by the Commission;

3. The PUC Administrator is authorized to sign all documents necessary to effectuate the provision of the above-referenced payroll services.
