**EVIDENTIARY HEARING RULES**

1. Lunch breaks shall be from noon to 2:00 p.m. each day; and other breaks in the proceedings may be given at a party's request.
2. The Rules of Evidence generally shall be guided by Rule 30 of the PUC's Rules of Procedure.
3. Witnesses shall be limited to those persons who have already participated or been made part of the administrative record (through filings and analytical studies).
4. Any witness testimony may be reduced to exhibit form.
5. Where a witness is referring to a document in the record, the party or its witness shall so clearly identify each such document.
6. During these proceedings, the ALJ may direct that any testimony given on direct examination be reduced to exhibit form.
7. Any party has the opportunity to make opening statements and/or closing statements, inasmuch as such statements do not exceed 30 minutes in duration.
8. Documentary evidence may be submitted subsequent to the closing of the hearing upon the stipulation of the parties.
9. All witnesses and parties shall be treated with courtesy and respect.
