REQUEST TO CLARIFY SCHEDULING ORDER

The Department of the Navy (Navy) hereby submits its Request to Clarify the Scheduling Order, issued on May 3, 2021.

On May 3, 2021, the Administrative Law Judge (ALJ) issued a Scheduling Order, setting forth the procedural schedule as it applied to the parties then involved in the matter, Georgetown Consulting Group and Guam Waterworks Authority. At the time the ALJ issued the Scheduling Order, the Navy was not yet a party. Since becoming a party, 1 no new scheduling order setting forth the procedural schedule as it applies to the Navy has been issued.

The Navy respectfully requests the ALJ clarify the Scheduling Order as it applies to the Navy, or otherwise issue a revised scheduling order, which sets forth a procedural schedule for the Navy.
