## PUC COUNSEL COMPLIANCE REPORT

## Background

This matter was previously before the Guam Public Utilities Commission [PUC] on December 29, 2008. The PUC issued an Order approving certain rate increases proposed by the Guam International Country Club [GICC]. <sup>1</sup> At that time, Georgetown Consulting Group [GCG] and GICC had entered into a Stipulation Re: Rates and Amendment to Rate Methodology. <sup>2</sup>

In its December 29, 2008 Decision and Order, the Commission imposed certain requirements upon GICC. GICC was ordered to propose a new panel of members ("comparable municipal facilities in the mainland United States"), consistent with the requirements set forth in P.L. 19-34 §23(b), no later than one (1) year from the date of the Order, or one-hundred-twenty (120) days before GICC files any new rate petition, whichever is sooner. <sup>3</sup> GICC was also required to propose a methodology using the newly determined panel members to set appropriate rates, and to disclose all data used to develop the panel and proposed rates, as soon as possible, but not later than when the proposed new panel was filed. <sup>4</sup>

PUC Legal Counsel was directed to monitor compliance by GICC with the terms and conditions of the Stipulation in this Docket. <sup>5</sup> Finally, GICC was ordered to pay the Commission's regulatory fees and expenses, including without limitation, consulting and counsel fees and the fees and expenses of conducting and transcribing the hearing proceedings. Assessment of PUC's regulatory fees and expenses is authorized pursuant to 12 GCA §12002(b) and 12024(b), and Rule 40 of the Rules of Practice and Procedure before the Public Utilities Commission. <sup>6</sup>

Recommendations

PUC Counsel recommends that the Administrative Law Judge [ALJ] conduct a hearing

In compliance with his duty to monitor compliance by GICC, PUC Counsel submits this report. GICC has not complied with its obligation to propose a new panel of members consistent with the requirements set forth in P.L. 19-34. Since GICC has not filed any

new rate petition, GICC was required to propose such panel of new members by

No methodology has been proposed by GICC using the newly determined panel members to set appropriate rates, in violation of ¶6 of the PUC's December 29, 2008

Finally, GICC has failed in its duty to pay the Commission's regulatory fees and

expenses. To date, the total amount owed by GICC to the PUC is \$29,427.34. On November 6, 2009, PUC Counsel sent a Demand for Payment of Regulatory Fees to GICC's Legal Counsel.<sup>7</sup> GICC has not paid any amount of the total amount due for

In particular, Counsel suggests that the ALJ consider the following: (1) revoking the Rate and Fee increases approved by the Commission on December 29, 2008, for failure of GICC to comply with its duties under the Stipulation and Decision and Order; (2) imposing penalties upon GICC of not more than five hundred dollars (\$500.00) for every violation, neglect or failure with regard to the Commission's Order <u>per day</u>; (3) requiring GICC to submit its financial records, including all bank records, to the Commission pursuant to 12 GCA §12005, for a determination of GICC's ability to pay the regulatory fees and expenses; (4) finding GICC in contempt for failing to comply with its obligations under the December 29, 2008 Order; (5) prohibiting GICC from filing any further rate application or petition with the PUC until such time as it complies with the December 29, 2008 Order.
