**ORDER**

On April 29, 2010, Guam Telecom, LLC ["GT"] filed with the Guam Public Utilities Commission [PUC] its General Exchange Tariff No. 1.<sup>1</sup> Previously, on May 28, 2009, GT was issued a Certificate of Authority to provide resold and facilities based local exchange services in Guam; however, no such services were to be provided until GT filed and obtained PUC approval of its tariff for said services.<sup>2</sup>

PUC Counsel has filed his due diligence report, which reviews GT's tariff filing. Counsel recommends approval of GT's General Exchange Tariff No. 1, as the filing is in accordance with 12 GCA §12106. Counsel recommends that the tariff, in the form filed by GT with the PUC on May 1, 2010, be approved, but the effective date be changed to the date of this Order.

On May 10, 2010, PUC published public notice of GT's request for approval of its tariff and invited public comments regarding the proposed tariff. A deadline of May 24, 2010 was set for interested parties to file public comments regarding the tariff. No comments were received by PUC in response to this notice.

Upon consideration of the record herein, review of General Exchange Tariff No. 1, the PUC Counsel Report, and for good cause shown, on motion duly made, seconded and carried by the affirmative vote of the undersigned Commissioners, the Commission hereby ORDERS that:

1. Guam Telecom LLC's General Exchange Tariff No. 1 was properly filed pursuant to 12 GCA §12106(a), which requires that telecommunications companies such as GT file tariffs indicating the rates and charges and the classifications terms and conditions of its telecommunications services.

2. General Exchange Tariff No. 1 is hereby approved and adopted.
3. General Exchange Tariff No. 1 shall be effective as of the date of this Order. A change in a tariff may not be effective except upon thirty (30) days prior notice to the Commission, unless otherwise ordered by the Commission. 12 GCA §12106(b).
4. Guam Telecom LLC is ordered to post this Order and its tariff on its website.
5. GT is ordered to pay for the PUC's regulatory fees and expenses incurred in this Docket, including, without limitation, consulting and counsel fees and expenses. Assessments of PUC's regulatory fees and expenses is authorized pursuant to 12 GCA §12002(b) and 12024(b), 12104, 12103, the Rules Governing Regulatory fees for Telecommunications Companies, and Rule 40 of the Rules of Practice and Procedure before the PUC.
