COMES NOW, the GUAM POWER AUTHORITY (GPA), by and through its counsel of record, D. GRAHAM BOTHA, ESQ., and hereby files GPA's Petition for the Public Utilities Commission of Guam to review and approve GPA's request for approval of the contract with TEMES, Inc. for the Macheche CT Repairs, as follows:

### **BACKGROUND**

The Guam Power Authority contracted with TEMES, Inc. for PMC services for Macheche CT. The Macheche Combustion Turbine (CT) is available but limited in operation to emergency use. The turbine generator has exceeded the recommended service life of 25,000 hours. TEMES, the PMC contractor for the Macheche CT has recommended the replacement of the turbine package with a fully refurbished gas turbine to prevent catastrophic failure caused by extending operations over the maximum run time. The CCU in Resolution FY2022-28 has approved GPA's request to contract for the generator repairs for Macheche CT through the PMC, TEMES, Inc., in the amount of \$3,953,417.60 using revenue funds.

### **DISCUSSION**

GPA hereby petitions the PUC, pursuant to the Contract Review Protocol for the Guam Power Authority, approved by the PUC, to review and approve the contract with TEMES, Inc.

for generator repairs for Macheche CT. In support of this Petition, GPA hereby provides the PUC with Consolidated Commission on Utilities (CCU) Resolution No. FY2022-28, which authorizes the General Manager to proceed with the contract with the PMC, subject to PUC approval. Said resolution and its exhibits are attached herein as Exhibit A, and incorporated by reference herein as if fully set forth.

### **CONCLUSION**

The PUC should approve GPA's request to proceed with the contract with TEMES, Inc. in the amount not to exceed \$3,953,417.60 for the generator repairs of Macheche CT. The Macheche CT unit is essential to the island wide power system, and the contract is reasonable, prudent, and necessary.

WHEREAS, the Macheche unit is available but limited in operation to only emergency use; and WHEREAS, TEMES, the Performance Management Contractor (PMC) for the CT has recommended the replacement of the turbine package with a fully refurbished gas turbine to prevent catastrophic failure caused by extending operations over the maximum run time; and

WHEREAS, TEMES issued a request for bids for this project and 3 bids were submitted for consideration from Field Source-Energy Services, TransCanada Turbine, and Gas Turbine Investments; and

WHEREAS, a GPA/TEMES evaluation committee determined Gas Turbine Investments to be the lowest responsive bidder at a cost of \$3,953,417.60; and

WHEREAS, GPA and the PMC intend to minimize the downtime of the unit, complete the necessary work, and return the unit to service as soon as possible to support the IWPS; and
