INTRODUCTION

COMES NOW the **GUAM SOLID WASTE AUTHORITY (GSWA)** and respectfully petitions the **GUAM PUBLIC UTILITIES COMMISSION (PUC)** to review and approve the contract entered into between GSWA and Pacific Unlimited, Inc. dba Fleet Services for fleet repair services.

BACKGROUND

On August 23, 2022, GSWA issued Invitation for Bid (IFB) No. GSWA 0008-22

soliciting for the qualified companies to provide maintenance and repair services for GSWA's

light, medium, and heavy vehicles and equipment.

Three prospective bidders acquired a bid package, and two bidders responded. The two

bidders were Pacific Unlimited Inc., dba Fleet Services (Fleet Services) and Triple J. Express Tire

& Lube Inc., dba Triple J Commercial Tire.

On September 8, 2022, the two bids were opened publicly. Fleet Services was determined

to be the lowest responsive and responsible bidder, having submitted a bid that offered to provide

fleet repair services at the lowest price.

The total contract amount for five years as offered by Fleet Services and agreed upon by

GSWA is estimated to be approximately One Million One Hundred Thousand Dollars

(\$1,1000,000.00) for the first year, plus an additional Four Million Four Hundred Thousand

Dollars (\$4,400,000.00) for four additional 1-year periods (or \$1.1 Million per fiscal year), subject

to the mutual agreement of the parties and the availability of funds.

On September 14, 2022, GSWA issued a Notice of Intent to Award the contract to Fleet

Services. The award was approved by the GSWA Board of Directors on September 22, 2022 in its

Resolution No. 2022-012. Said Resolution is attached herein as Exhibit 1 and incorporated in full

by this reference.

No protest of the award to Fleet Services was or has been made, and the period for filing a

protest under 5 GCA § 5425(a) ended on September 28 (i.e., 14 days after the notice of intent to

award was given to Fleet Services on September 14).

DISCUSSION

The PUC has jurisdiction and authority to hear this Petition pursuant to 12 GCA § 12105

and the Order establishing a Contract Review Protocol for GSWA. See, GSWA DOCKET 19-02 &

ADMINISTRATIVE DOCKET dated July 25, 2019.

GSWA's entire operation as an agency is grounded in its mission to provide Guam with a

safe, efficient and effective solid waste disposal system that protects the health, safety, and welfare

of Guam and the public, while also protecting the environment. A key factor in the success of this

mission is the reliability of the equipment and the fleet of refuse trucks and vehicles that are

necessary to collect, dispose, and recycle the waste.

At all times, the fleet must consistently be maintained and kept in good working order so

that GSWA can perform its duty to provide waste disposal services, otherwise the public's health

will be threatened. Moreover, the equipment and the fleet represent costly investments made with

public funds. It is critical that each vehicle be kept safe, reliable and can stay on the road for the

optimum amount of time.

CONCLUSION

The contract with Fleet Services to maintain and repair GSWA's light, medium, and heavy

vehicles and equipment is essential to the operations of GSWA and in the best interests of the

Guam and its residents. The terms and cost of the contract are fair and reasonable to all concerned,

and the procurement was made in compliance with Guam law. For all the foregoing reasons,

GSWA submits that the instant petition for the PUC to review and approve the award of a contract

to Pacific Unlimited Inc. dba Fleet Services for the provision of fleet repair services should be

GSWA Board Resolution No. 2022-012 RELATIVE TO PETITIONING THE PUBLIC UTILITIES COMMISSION (PUC) FOR THE APPROVAL OF THE AWARD TO PACIFIC UNLIMITED, INC. dba FLEET SERVICES FOR FLEET REPAIR SERVICES.

WHEREAS, on Tuesday, August 23, 2022, the Guam Sold Waste Authority (GSWA) issued an Invitation for Bid (IFB) No. GSWA008-22 to solicit qualified companies to provide Fleet Repair Services for all of GSWA's light, medium, and heavy vehicles and equipment; and

WHEREAS, the Authority had received three (3) prospective bidders that acquired bid documents, but only two (2) were submitted by the submission deadline of September 8, 2022 at 10:00 a.m.; and

WHEREAS, bids were publicly opened on Thursday, September 8, 2022 at the GSWA Conference room; and

WHEREAS, Pacific Unlimited dba Fleet Services was the only company that submitted a bid offer for Fleet Repairs (Item 1.0), while Triple J Express Tire & Lube, Inc. dba Triple J Commercial Tire submitted a "No Bid" for Fleet Repairs (Item 1.0); and

WHEREAS, Pacific Unlimited dba Fleet Services met the requirements of the bid and offered the lowest cost bid of \$73.50 per hour for In-Shop Fixed Rate and \$105.00 for Out-of-Shop Fixed Rate; and

WHEREAS, the total contract amount for the Fleet Repair Services at the prices offered are estimated to be approximately One Million One Hundred Thousand Dollars (\$1,100,000.00) for the first year, and an additional Four Million Four Hundred Thousand Dollars (\$4,400,000.00) for four (4) additional 1-year periods subject to availability of funds.

WHEREAS, GSWA issued Notice of Intent to Award to Pacific Unlimited dba Fleet Services on September 14, 2022; and

WHEREAS, funding for this contract will be from GSWA Operations Fund; and

THEREFORE, BE IT HEREBY RESOLVED by the Board of Directors as the Governing Body of the Guam Solid Waste Authority authorizes Management to petition the Public Utilities Commission (PUC) to review and approve the award to Pacific Unlimited dba Fleet Services for Fleet Repair Services (Item 1.0), in accordance with the Contract Review Protocol for the Guam Solid Waste Authority.
