MINUTES

The Guam Public Utilities Commission [PUC] conducted a special meeting commencing at 6:30 p.m. on May 16, 2024, pursuant to due and lawful notice. The meeting was called to order at 6:35 p.m. **Commissioners Jeffrey C. Johnson, Peter Montinola, Rowena Perez-Camacho, and Doris Flores-Brooks** were in attendance. The following matters were considered at the meeting under the agenda included as *Attachment "A"* hereto.


The Chairman announced that the session would begin in open session and then invited Administrative Law Judge Frederick Horecky (ALJ Horecky) to explain the evening's agenda. ALJ Horecky informed the commission that he had sent a letter recommending the commission go into executive session to discuss a matter of pending litigation, pursuant to 5 GCA Section 8111(C)(1). Following this, Chairman Johnson asked for a motion to enter into executive session. Commissioner Montinola moved to enter into executive session, which motion was seconded by Commissioner Perez-Camacho. The motion passed unanimously.

Upon returning to open session, Commissioner Montinola motioned for the authorization to file an amicus brief in the Supreme Court of Guam to support the petition of GWA to seek interlocutory appeal of the Superior Court decisions in the pending GWA-Core Tech litigation. This motion was seconded by Commissioner Perez-Camacho. The motion passed unanimously.

There being no further business, the Commissioner Montinola moved to adjourn the meeting, which motion was seconded by Commissioner Perez-Camacho. The motion passed unanimously and the meeting was adjourned at 7:54 p.m.
