Dear Attorney General Moylan:

This serves to amend the Public Utilities Commission ("PUC") Freedom of Information Act ("FOIA") FY2024 Annual Report dated January 31, 2025, which was emailed and delivered to your office on January 31, 2025.

Pursuant to the requirements of 5 G.C.A. §10107, the PUC hereby submits its FOIA Annual Report for fiscal year 2024, as follows:

1. During FY2024, the PUC responded to all FOIA requests and made no determination not to comply with any FOIA requests for records.
2. As of September 30, 2024, there were no FOIA requests for records pending before the PUC.
3. During FY2024, the PUC received and responded to one (1) FOIA request for records and processed it in a timely manner according to law.
4. The median number of days for PUC to process this FOIA request for records was within the required four (4) days, as the extent of the FOIA request for records received in FY2024 was not voluminous in nature.

PUC regularly receives informal requests to inspect or obtain copies of its records, which are normally processed within several business days of the requests, and the expenses were incurred by the PUC, as processing said FOIA requests were at a nominal cost.

The PUC now has three (3) full-time employees (i.e., an Administrator, Administrator-in-training and Administrative Assistant), who are responsible for PUC's administration and day-to-day operations; including, but not limited to, the task of responding to FOIA requests for information and/or records.
