Dear Attorney General Moylan:

Pursuant to the requirements of 5 G.C.A. §10107, the Public Utilities Commission ("PUC") hereby submits its Freedom of Information ("FOIA") Annual Report for fiscal year 2024, as follows:

1. During FY2024, PUC made no determination not to comply with any FOIA request for records.
2. As of September 30, 2024, there were no FOIA requests for records pending before the PUC.
3. The PUC did not receive any FOIA requests for FY2024.
4. In prior fiscal years, the median number of days for PUC to process FOIA requests were within the required four (4) days, as the extent of the FOIA requests received were not voluminous in nature. PUC regularly receives informal requests to inspect or obtain copies of its records, which are normally processed within several business days of the requests, and the expenses were incurred by the PUC, as processing said FOIA requests were at a nominal cost.
