Good afternoon, Anthony!

I spoke to our AGMO, who confirmed that GPA owns Piti 7. GPA used to have an ECA, but it expired in about 2016 and the plant was turned over to GPA at that time. Piti 7 was not part of any prior or current CT PMC contract because of the ECA. GPA intends to include Piti 7 in the new CT PMC contract.

The reason TEMES is acting as capital improvement PMC only is because there was a provision in the old CT PMC that allowed us to extend limited PMC services to plants in dire need, which Piti 7 was (and still is). Please see attached pdf at page 62 (Amendment No. 2).
