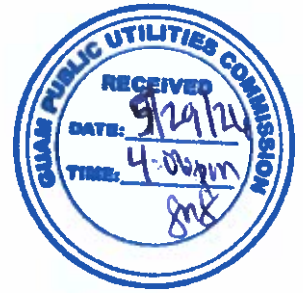

THIS MATTER, came before the Administrative Law Judge [“ALJ”] on April 3, 2026, pursuant to the Guam Power Authority’s [“GPA”] Petition to Amend the Ukudu Power Plant Energy Conversion Agreement to Permit GPA to Pay for Additional Testing and the Guam Public Utilities Commission [“PUC”] was to decide this matter during their May 7, 2026 hearing. However, on May 6, 2026, Doosan Ukudu Power LLC [“Doosan”], a non-party to this matter, filed an opposition to GPA’s Petition and this opposition was found to be untimely and the PUC tabled this matter until its next hearing on May 21, 2026. Doosan filed a second opposition in this matter on May 15, 2026 and it filed a notice of its Government Claim against GPA in this matter on May 21, 2026. The second opposition and notice are not a motion to intervene which is required for a non-party to intervene and subsequently participate in this matter pursuant to Rule 8, PUC Rules for Practice and Procedure [“PUCRPP”]. During the May 21, 2026 hearing, as the PUC was deliberating its next procedural steps in this matter, Counsel for Guam Ukudu Power LLC [“GUP”], a non-party to this matter, requested to participate by making statements, and that request was denied because GUP had not filed a motion to intervene pursuant to Rule 8, PUCRPP. The PUC instructed the ALJ to issue a scheduling order setting deadlines to file motions to intervene and answers pursuant to Rule 8, PUCRPP. Accordingly, the ALJ hereby **ORDERS** the following:

1. The following briefing schedule is hereby ordered for any motions to intervene by non-parties to this matter and remains subject to change at the discretion of the ALJ:

**Filing Deadline For
Motions to Intervene:**

June 12, 2026 at 5:00 P.M.

Non-Parties who are interested in participating in this matter shall file and serve on GPA and Doosan or GUP, no later than this date and time, their respective motions to intervene pursuant to Rule 8, PUCRPP. Such petitions to intervene shall set out clearly and concisely the facts supporting the petitioner’s alleged right or

interest, the grounds of the proposed intervention, and the position of the petitioner in the proceedings, so as fully and completely to advise the parties and the PUC of the specific issues of fact or law to be raised or controverted.

**Filing Deadline for
Answers to Motions
To Intervene:**

June 26, 2026 at 5:00 P.M.

If any petitions to intervene are filed, GPA, Doosan, and GUP may file an answer to such petition and serve it on GPA and Doosan or GUP no later than this date and time.
